The undersigned is directed, by order of the Governor to say that the Governor is pleased to approve of the proposal for the establishment of a degree college for girls' at fazzz Scrampore in the district of Hooghly with effect from the scatterie session, 1981-82 subject to the following terms and conditions to

- 1) The organisers shall have to provide the required land, as assessed by the University Inspecting Year by way of registered deed, free from all encumbrances to the college authorities. The site shall have to be approved by the affiliating University:
- 2) The organisers shall be required to provide adequate accommodation, essential furniture, equipment, books, etc. for purpose of the sollege as per standard laid down by the University at their ean cost;
- 5) Pending construction of the college building, classes may be held in buildings of nearby educational institution by suitable adjustment of time tables with the approval of the affiliating University;
- 4) We existing Higher Secondary Schools in the locality should be taken over by the Hamagement of the College and run as integral part of the college;
- 5) Teaching and Hon-teaching staff, as may be approved by Govt. shall be appointed after observing norms prescribed in Acts and Rules in force. The college may, for the present, be affiliated in English, Bengali, Sanakrit, History, Philosophy, Political Science, Education or Hindi as may be recommended by the affiliating University
- 6) The college will be run by a Governing Body to be constituted in the manner prescribed in the Statute of the affiliating University. Pending constitution of such Governing Body. Ad-hec Governing Body may be constituted as follows for running the college at the initial stage;
 - 1) District Angistrate where the college is located in district headquarter or the Sub-Divisional Officer in other cases ... President.
 - 11) One nominee of the Government ... Member.
 - 111) One nominee of the D.P.I. ... Member.
 - iv) One nominee of the affiliating University.

- w & vi) Two representatives of the ...
 - vii) Principal of the College ... Secreta. One of the representatives of the Organizing Committee will however set as a Secretary till the Principal is appointed.
- 7) No special constitution of the Governing Body shall be seepted by the Government;
- 8) Terms and conditions for the purpose of affiliation as laid down by the University are to be fulfilled.
- 2. The Governor is also pleased to approve of the creation of teaching and non-teaching posts in the college as an detailed in the Annexure in the usual scales of pay with effect from 1981-82 session or from the date(s) of filling up of the posts, whichever is later.

Recruitment of all the teaching posts including Principal should be filled up on recommendations of the West Bangal College Service Commission.
