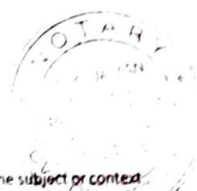

WHERE AS

A) FIRST PARTY is a Higher Educational Institution named:

STATE INSTITUTE OF PHYSICAL EDUCATION FOR WOMEN, HASTINGS HOUSE, ALIPORE, KOLKATA, is a Higher Education Institution, is establish in the year 1975 under the direct control of Higher Education Department, Govt. of West Bengal and is engaged in imparting teachers training for aspirant female students in the field of Physical Education under the academic guide lines of NCTE and The University of Calcutta.

F) The First Party presently functions all activities from its own premises at Hastings House 20B, Judges Court Road, Alipore, Kolkata-27. It has no other branch, wing, subsidiaries or extensions existing at present.

B) First Party and Second Party believe that Collaboration and cooperation between themselves will promote healthy teaching-learning environment for more effective use of each of their resources, and provide each of them with enhanced opportunities.

C) The Parties intent to cooperate and focus their efforts in cooperation and support within area of Higher Education, Development of teaching skill, Managerial efficiency and socio-cultural aspect of a teacher based on teaching internship course.

D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

E) The Second Party, is a Higher Educational Institution named:

SERAMPORE GIRLS' COLLEGE, SERAMPORE, HOOGHLY is a General Degree College for Women's establish in the year 1981 located at 13, T.C. Goswami Street, Serampore, West Bengal 712701 which is affiliated to the University of Calcutta.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

**CLAUSE 1
AREAS OF CO-OPERATION**

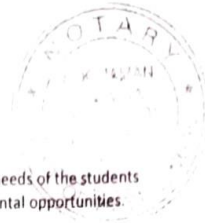
1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institutions. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable

teaching and sports skills, organization of sports events keeping in minds the needs of the students vis-à-vis the placement needs of the educational institutes and other departmental opportunities.

1.3 Both the institution will do;

- a) Mutually exchange of the expertise available in both the colleges in different academic and sports, Physical Education and yoga activities.
- b) Availing the training facilities available in both the campuses for physical education, yoga, exercise science and sports training and competition purposes.
- c) Faculty and student exchange programme for mutual benefit and sharing of the knowledge.
- d) Organize Seminars/ Workshops as well as consultations on regular basis.

1.4 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

1.5 There is no financial commitment on the part of STATE INSTITUTE OF PHYSICAL EDUCATION FOR WOMEN, HASTINGS HOUSE, ALIPORE, KOLKATA, the First Party to take up any programme mentioned in the MOU, if there is any financial consideration, it will be dealt separately outside the ambit of this MOU as per the demand of the emergent situation.

CLAUSE 2
VALIDITY

- This agreement will come into effect from the date of this agreement and shall be valid for three years from that date unless sooner terminated, revoked or modified by mutual written agreement between the parties and may be extended by mutual written agreement.
- This Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations, and will be absolved of all prior responsibilities.

CLAUSE 3
RELATIONSHIP BETWEEN THE PARTIES

- It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be interpreted as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party, duly sanctioned by the Department of Higher Education, Government of West Bengal. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding

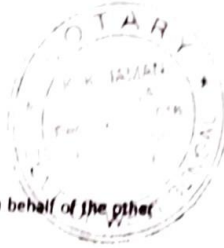

REPORT OF INTERNSHIP PROGRAMME

Memorandum of understanding between State Institute Of Physical Education for women Hastings House, Alipore ,Kolkata, West Bengal and Serampore Girls' College, Serampore, Hooghly, West Bengal for resource sharing, skill development and outcome based Teaching Learning Internship Programme. It was held from 10.05.2023 to 23.05.2023. 14 trainee teachers came to conduct the class. There were 18 hours of classes (practical -12 hours, theory- 6 hours). 47 students were present in this internship programme.
